COVID-19 UPDATE

Petersburg currently has 1 recovered case of COVID-19. There are currently no active cases of COVID-19 in the community. Our first positive is fully recovered and is cleared by the State of Alaska Epidemiology.

PMC has tested 62 patients for COVID-19; 1 recovered positive case, 53 tests have returned negative and 8 tests are still pending.

PETERSBURG MEDICAL CENTER

PMC is taking all necessary precautions to make sure staff and patients stay safe.

- PMC sent all non-essential staff home to work.
- All PMC meetings are now virtual to maintain social distancing.
- PMC has implemented a mask policy for all staff and patients; mask to be worn always in the facility.
- We are working on developing telehealth services for patients to have virtual visits with their provider.
- Rehabilitation department is providing their services via telehealth.

PLAYGROUND & SHELTER CLOSURE

The Borough's Parks and Recreation Department have closed all play structures and shelters. Open air areas and trails remain open. Please stay home if you are showing symptoms, keep a 6' distance from others, and keep dogs on leash. If you are actively exercising (running/biking) at least double that distance.

STATE TRAVEL MANDATE

The State of Alaska has instituted a mandatory 14-day quarantine for all arriving passengers. In accordance with the State mandate, accommodations have been made at the airport for travelers to be met and declaration forms to be provided. The forms are also available at https://ready.alaska.gov/form
The failure to follow this order is punishable by a fine of up to \$25,000, or imprisonment of not more than one year, or both pursuant to Alaska Statute 12.55.035 and Alaska Statute 12.55.135
