- **B. Mayor's Letter to Senator Mark Begich** Mayor Jensen informed of his letter to Senator Begich requesting continued operation of US Coast Guard vessels from the Petersburg port. The Anacapa is believed to be one of the ships to be retired when the Coast Guard replaces 110' vessels with 154' fast response cutters.

During the report, Public Works Director Hagerman updated the Assembly on the revised solid waste voucher program and informed that an USDA official has nixed the RAC project that was planned for Banana Point (floating access dock).

13. UNFINISHED BUSINESS

- **A. Juneau Appeal of Petersburg Borough Boundaries** Oral argument will commence at 3:00 p.m. Wednesday, September 4 in Juneau. Judge Menendez has allotted only one hour total for all three parties to make their case. Mayor Jensen or Manager Giesbrecht will attend the court session.
- **B. Redistrcting** The Riley Plaintiffs have challenged the Redistricting Board's adopted Plan. Legal counsel does not believe the challenge will affect the adopted redistricting of Southeast.
- C. Ordinance #2013-09: An Ordinance Providing for Chapter 14.20 of the Municipal Code, Entitled "Municipal Harbors", Updating Current Language to Reflect Borough Incorporation; and Providing for the Municipal Harbors Located within Service Area 1 Only, the Limiting of Fish Cleaning to Designated Cleaning Stations and Prohibiting the Disposal of Fish or Animal Waste and Parts By a unanimous Roll Call Vote, ordinance #2013-09 was approved in final reading.

D. Ordinance #2013-10: An Ordinance Updating Chapter 4.04 -Entitled "Purchasing", Updating Current Language to Reflect Borough Incorporation and to Provide Uniformity Between the Code and the Borough's Standard Specifications Manual. 3rd and Final Reading. The ordinance was unanimously approved in final reading by Roll Call Vote.

E. Kake Access EIS A proposed letter with comments to the draft Purpose and Need Statement for the Kake Access was reviewed. Mayor Jensen believed the Assembly needs more information on the projects before making too many negative comments. The projects can be done without a road or power line going through Kupreanof. If the money is not spent in our area where currently appropriated, the funds will be given to another community. The projects are complicated, with many variables. After considerable discussion and debate, the assembly amended the proposed letter and by a Roll Call vote of 6-1 (member Strand opposed) authorized the amended letter be sent. The letter focused on three issues: Need to combine the Intertie and Access Projects; consider improving existing transportation alternatives; and the City of Kupreanof's rights as a roadless community need to be observed.

F. Response from ADOT/PF Regarding Herbicide and Pesticide Applications in the Borough Assembly members and resident Barry Bracken expressed their discontent with the response from ADOT. The department appeared to know what was best for our local community and did not address our concerns. The letter only expressed existing regulations and guidelines. After considerable discussion, by a unanimous voice vote, authorization was given to prepare a draft response letter to ADOT to be considered at the August 19 meeting.

The meeting was reconvened at 1:32 p.m. with all assembly members in attendance.

By a Roll Call Vote of 5-2 (Assembly members Strand and Havrilek opposed) the resolution was approved. Strand expressed her concerns that using the word "non-essential" would encourage ADOT to lessen the service already provided to Petersburg. General discussion was held regarding future ferry service in and out of Petersburg.
